For the purpose of the admission procedure in accordance with Section 58 paragraph 3c of Act no.131/2002, the data controller shall process data on the achieved education, including study results and results of activity related to the study program to which the applicant is applying.

In the case of successful applicants, the above mentioned data may also be used by the data controller for the purpose of registration to study.

Statistical purpose:

In accordance with Section 58 paragraph 4 of Act no.131/2002, the data controller may provide data processed for the purposes of the admission procedure to other legal entities and natural persons for statistical purposes.

Withdrawal of consent does not affect lawfulness of the processing of personal data based on consent given prior to its withdrawal. The data subject may withdraw the consent in the same way as it was granted, reporting it to the data controller.
