### Information about personal data protection

Personal data which applicant (hereinafter referred to as "data subject") presents in this application form to study at the higher education institution (hereinafter referred to as the "data controller") are processed by data controller in accordance with Act No. 18/2018) and on the Protection of Personal Data and on the Amendment of Certain Acts (hereinafter referred to as "Act No.18/2018") and No. 13/2002 Coll. On Higher Education Institutions and on the Amendment and Supplementation of Certain Acts (hereinafter referred to as "Act No. 131/2002").

#### Purpose of personal data processing

#### Admission procedure and registration to study:

For the purpose of admission procedure in line with Section 58 paragraph 3a of Act No.131/2002, data controller shall process following personal data:

Name,Surname.

Maiden surname,

Academic and scientific titles,

- Birth number,

- Date of birth,

- Place of birth.

- Permanent address,

- Sex

- Student's photograph,

- Student's citizenship,

- Telephone number (if provided by the student),

- And email address (if provided by the student),

- In case of foreign citizen, also address in the Slovak Republic is registered; birth number is registered if assigned to them by the Ministry of Internal Affairs.

For the purpose of the admission procedure in accordance with Section 58 paragraph 3b of Act No.131/2002, data controller shall process data on the former employment or on the current employment of the applicant.

For the purpose of the admission procedure in accordance with Section 58 paragraph 3c of Act no.131/2002, data controller shall process data on the achieved education, including study results and results of interest activities related to the study programme to which the applicant is applying.

In case the applicant is successful, above mentioned data may also be used by the data controller for the purpose of registration to study.

### **Statistical purposes:**

In accordance with Section 58 paragraph 4 of Act No.131/2002, the data controller may provide data processed for the purposes of the admission procedure to other legal entities and natural persons for statistical purposes.

### Processing of personal data that is not necessary under a special regulation:

In case that data controller requires documents containing personal data, processing of which is not necessary under a special regulation (eg Section 58 and Section 73 paragraph 3 of Act No. 131/2002), it is necessary for the data controller to state the purpose of personal data processing in accordance with Act no. 18/2018 and to process these data on the basic of the data subject's consent to processing of their personal data.

Granting of consent to the processing of personal data which are contained in the annexes provided with the application for study may be indicated in the application form. In accordance with Section 14 paragraph 3 of Act no.18/2018, the data subject is entitled at any time to withdraw a consent to the processing of personal data. Withdrawal of consent does not affect lawfulness of the processing of personal data based on consent prior to its withdrawal. Data subject may withdraw the consent in the same way as it was granted, reporting it to the data controller.
